Consciousness

Funding a cohesive program of consciousness study and its application to societal laws

My name is Bob Good. I know from the papers that billionaires fund causes within various communities to bring truth and kindness into the world. I submit that this particular request for funding and its product will be used by all communities' billionaires' support globally. This is the science of the arguments you make when you work for the good of others.

My request is centered around consciousness science and what we are coming to understand by mathematical proof. Through a series of smaller donations, we hope to generate an initial document summarizing the research findings across a variety of disciplines that will change human understanding and produce a document called The Standard Model of Consciousness, incorporating physicalist and non-physicalist models into one model.

We plan to raise 450 million dollars in nine 50 million dollars tranches from select billionaires only. The reason for this is in answer to Dean Radin's document of need, what funding Consciousness Science needs.

I want to give you an example of an observation in consciousness science and its significance. This category or discipline is called Children Who Remember Prior Lives. This kind of observation was once considered an anomaly, something science could not explain. But by connecting it to other anomalous observations and disciplines we can use them all as fractals to create a mathematical proof of our reality.

The following case study is about a white boy who remembers dying in a fire in Chicago as a black woman in 1993. These are reincarnation stories told by children themselves.

On March 16, 1993, at about 4 a.m., a faulty space heater set a room on the first floor of the Paxton hotel, 1432 N LaSalle Street, Chicago, Illinois, ablaze.

The blaze quickly spread to the upper floors, where many of the hotel's 130 residents got trapped.

This was how the New York Times reporter, Don Terry, reported the event.

15 killed as Flames sweeps residence hotel in Chicago

March 17, 1993

At least 14 people were killed and more than 25 injured early today when a ferocious fire swept through a transient hotel on the city's Near North Side, trapping tenants and sending others leaping from windows to escape the flames.

The fire spread so quickly that before firefighters could set up ladders, several terrified residents shimmied down bed sheets or jumped from smoke- and fire-filled rooms two to four stories above the rain-slicked street.

At least one woman died when she jumped from a window trying to escape the inferno, and another pleaded for help, screaming: "The fire's burning me. The fire's burning me." She survived, but her fate is unclear.....

Pamela Robinson and Luke Ruhlman

February 20, 2015

A 2-year-old Cincinnati boy, Luke Ruhlman, kept mentioning the name Pam as soon as he learned to talk.

At the age of 5 years, her curious mom asked, "Who Is Pam? "

"I was; I used to be Pam. I died, I went to heaven, I saw God, who eventually pushed me back down.

I woke up as a Boy, and you named me Luke."

Mother's Question: Do you remember how you died?

Answer: There was a fire, and I jumped off the burning building to my death—a tall building in a big city. I used to walk a lot and took the train.

Mother's Question: Is it Chicago?

Answer: Yes, Chicago; I remember it was in Chicago.

"When I was a girl, I used to have black hair; I used to have earrings like that."

Pam Robinson was an African-American Chicago woman who died in a fire at the Paxton Hotel in 1993. She had died after jumping through a window to escape the inferno. Luke gestured with his hands like he was about to jump off a building.

"The Ghost inside my child" TV show became involved. The TV show investigated Luke's story and put Erika in touch with Pamela Robinson's family.

Ericka Ruehlman got a photo of Pamela and added several fake photos. Luke accurately recognized Pamela Robinson's photo.

"I know someone I can recognize,"; he uttered while pointing to Pamela Robinson's photo.

A Pamela Robinson family member told Ericka that Pamela Robinson, a black woman, had enjoyed listening to Stevie Wonder's songs; she played the keyboard a lot.

Luke as an infant, had a little piano as his favorite toy. Luke also enjoys Stevie Wonder-era music.

Luke, after the age of 5 years, stopped talking about Pam.

The science of Luke's story tells us that the human life force or Soul has no gender, social, or racial identity. The odds against chance calculations is that Pamela Robinson returns as Luke Ruehlman. This is not an unusual case study.

Hanan Monsour died and came back as Suzanne Ghanem and started at 16 months, recalling her old life. When reunited with her prior family as Hanan, Suzanne identified 15 prior relatives by name, this by the age of 5. Those family members came to accept Suzanne as Hanan.

Charles Leininger as a child, remembered dying as a navy pilot during World War II in the Pacific. He remembered the ship he was on, the Natoma. He was James Huston in that life, and when young Charles was taken to a reunion of Natoma veterans, they accepted him as who he was in his previous life.

I could go on with more examples but they all amount to the same thing, the odds against chance of these people knowing about their previous life is certainty. Being able to convince others of who they were is because they know things just like the person they are trying to convince. They were who they claim because both parties remember the same facts in the same way because they shared a common experience.

These stories are examples of a category of consciousness science called children who remember prior lives. The University of Virginia has been studying cases like this for over 60 years.

This kind of story was once considered a scientific anomaly, something our science could not explain. But once they are connected to other categories as fractals, such as NDEs and past life regression, they prove mathematically that this is our reality.

I am asking you for several smaller interconnected donations whose benefit of doing this will add up to more than the sum of their parts. Once complete, its use will be global. The following explanation will also show where we are asking others to support this effort. The overall plan will also be there, laying out the need for 450 million dollars for consciousness research.

The overall need request is 450 million dollars and was written by Dean Radin.

This plan emphasizes four areas, Education, Empiricism, Theory Development, and Applied research.

This request to you, each individual billionaire, is for 50 million dollars. What follows is how and where that 50 million will be spent and on what. Each recipient is a luminary in the field of Consciousness Science, each with a different focus. Our mission at TIFACS is to infuse consciousness science with resources and build connectivity to increase and improve our understanding of ourselves and each other. **I would trust each recipient would do as this plan requests or return the gift/donation.** Each donation is given to the named individual to manage for the benefit of consciousness science. They all know of this effort to a greater or lesser degree.

RFF #1 (Request for Funding) Jim Tucker, The University of Virginia, Children Who Remember Prior Lives, 5 million dollars.

Jim B. Tucker, M.D. Director of the **Division of Perceptual Studies**, University of Virginia Health System. He studies **Children Who Remember Prior Lives**.

Now two things; first, when we use odds against chance calculations through thousands of cases, the fact that our consciousness transcends our permanent bodily death is now a calculable certainty in each category of this science. When we use each category as a fractal, we get mathematical proof that the story you just read is true, and we proved it and a new reality with it. With that mathematical proof, we make the case that souls can change gender, race, and religion from life to life. That scientifically makes the case that LGBTQ is normative. That scientifically, apostasy, blasphemy, and celibacy should be removed from all religious canon. Scientifically we can use this information to reshape our society.

The request is for 5 million dollars to support this research at UVA, and the ask is for Jim to take out in one compendium the transgender cases he and the late Ian Stevenson have compiled, like the first example. Using odds against chance calculation, these observations are a certainty. Still, currently, there is no way to connect them to our reality scientifically, even though it could be done and prove scientifically that being gay, straight, or transgender is just a common experience of consciousness and not a disorder. Their observations alone can't prove that, but if he aggregates them, we can connect them to other observations in consciousness science and make that case.

So, we are providing a list of requests that your contribution will thread together to present this science in a cohesive and easy-to-understand explanation so that all causes you support can use this information to refute the lies and lack of knowledge on the subject and to educate the world.

The asks: We are asking Jim Tucker to lift and separate

1-Transgender narratives,

2-Narratives by region (Mid-east, far east, west, etc.)

3-Narratives by religion.

This is to show that the effects we are documenting are universal.

4-These be contributed to the book The Standard Model of Consciousness, being cataloged by the University of Arizona under the observations section, and their mathematical information will be given to Jessica Utts so she can create and produce a fractal proof.

To that end, we want to aggregate the Landscape of observations and Lift transgender stories from the data pool/mine because this is our reality proven by mathematics.

RFF 2 Brian Weiss the University of Miami, Past Life Regression, 5 million dollars.

This category is Past Life regression. Rather than present a case study here refer to the past life regression of actor Glen Ford as our example. Simply google it.

Brian Weiss graduated from Columbia University and Yale Medical School and is Chairman Emeritus of Psychiatry at the Mount Sinai Medical Center in Miami.

The gift would be to the Psychiatry Mount Sinai Medical Center department at the University of Miami.

Brian Weiss, five million dollars, and the ask is to do the same thing we are asking of Jim Tucker. He regularly encounters the lives of the opposite gender when regressing individuals. Ultimately all these are observations of how consciousness manifests itself, and eventually, they become data points in our fractal proof.

The asks: We are asking Brian Weiss to lift and separate

1-Transgender narratives

2-Narratives by region (Mid-east, far east, west, etc.)

3-narratives by religion.

This is to show that the effects we are documenting are universal.

4-These be contributed to the book The Standard Model of Consciousness, being cataloged by the University of Arizona under the observations section. Their mathematical information will be given to Jessica Utts so she can create and produce a fractal proof.

5-Ask questions of the “Masters” regarding nonlocal consciousness and suggestions for studying it.

RFF 3 Pim van Lommel 5 million dollars Category NDE’s

NDEs are near-death experiences. Near Death, Experiences are cognitive events that occur when a person experiences bodily death. While there is not a transgender narrative here that I know of, whether you are gay or straight, you can experience an NDE. The landscape that the person experiencing the NDE describes is very similar to the landscape that Children who Remember Prior lives and Past Life Regression describe. There are enough data points between these groups to identify the landscape described as fractals of each other.

Explaining NDEs This is what Pim van Lommel says about the continuity of our consciousness.

“According to our concept, grounded on the reported aspects of consciousness experienced during cardiac arrest, we can conclude that our consciousness could be based on fields of information consisting of waves and that it originates in the phase-space. During cardiac arrest, the functioning of the brain and other cells in our body stops because of anoxia. The electromagnetic fields of our neurons and other cells disappear, and the possibility of resonance, the interface between consciousness and the physical body, is interrupted.

Such understanding fundamentally changes one's opinion about death, because of the almost unavoidable conclusion that at the time of physical death consciousness will continue to be experienced in another dimension, in an invisible and immaterial world, the phase-space, in which all past and present and future is enclosed. Research on NDE cannot give us irrefutable scientific proof of this conclusion, because people with an NDE did not quite die, but they all were very, very close to death, without a functioning brain.

The conclusion that consciousness can be experienced independently of brain function might well induce a huge change in the scientific paradigm in western medicine and could have practical implications in actual medical and ethical problems such as the care for comatose or dying patients, euthanasia, abortion, and the removal of organs for transplantation from somebody in the dying process with a beating heart in a warm body but a diagnosis of brain death.

There are still more questions than answers, but, based on the aforementioned theoretical aspects of the obviously experienced continuity of our consciousness, we finally should consider the possibility that death, like birth, may well be a mere passing from one state of consciousness to another."

This theory, as articulated by Pim, is supported by the narratives above. They are, in fact, fractals of each other. They are each an iteration, and they are self-similar—the donation to Utrecht University.

The asks;

1-Transgender narratives

2-Narratives by region (Mid-east, far east, west, etc.)

3-narratives by religion.

This is to show that the effects we are documenting are universal.

4-These be contributed to the book *The Standard Model of Consciousness*, being cataloged by the University of Arizona under the observations section. Their mathematical information will be given to Jessica Utts so she can create and produce a fractal proof.

We ask Pim to provide Jessica with matching fractal points from his observations that match the other categories. NDEs happen to transgender people, in all regions and all religions. The effects we are documenting are universal. These are contributed to the book *The Standard Model of Consciousness*, being cataloged by the University of Arizona under the observations section.

When we take all three views of this nonlocal consciousness, we get different perspectives of the same site, looking forward (remote viewing) and backward (past life regression). We also see that same landscape in the NDE observations.

How do the mechanics of this landscape and our travel through it work? Does this go directly to communicating with aliens in our local space?

There is one final notation to this, from the sum gifted to Utrecht University 10% of that sum of \$500,000 be set aside for Titus Rivas to use at his discretion in the advancement of out-of-body consciousness.

RFF 4 Jessica Utts, Chair of Statistics at the University of California – Irvine, to formalize the math, 5 million dollars.

She has done odds against-chance calculations of the various subsets we have discussed, but while that math points to certainty, it is not a proof. If she does the fractal geometry of her calculations, she “proves” this hypothesis mathematically.

Now several exciting things happen with this proof. First, it challenges any other evidence to be more factual and supports religious belief in an afterlife. This condition of science also includes all creatures with electromagnetic signatures, so all religions are present; it eliminates apostasy, blasphemy, and chastity as anything other than wrong and not founded in fact.

The donation would be to UCSD, The University of California at Irvine.

The asks: We ask Jessica Utts to

1-Provide the framework for the fractal proof that this is our reality. The landscape of observations will be aggregated and shown to be valid across all races and cultures. Transgender narratives, Narratives by region (Mid-east, far east, west, etc.), and narratives by religion we are documenting are universal.

4-These be contributed to the book The Unified Field theory of Consciousness, being cataloged by the University of Arizona under the observations section, and their mathematical information will be given to Jessica Utts so she can create and produce a fractal proof.

RFF 5 Center for Consciousness Studies 10 million Dollars

Stuart Hameroff, Center for Consciousness Studies at the University of Arizona.

Stuart Hameroff's research pursued microtubule information processing and anesthetic action. In the mid-1990s, he teamed with eminent British physicist and Nobel Laureate Sir Roger Penrose to develop a controversial quantum theory of consciousness ('orchestrated objective reduction', 'Orch OR') based on microtubule quantum computing. Harshly criticized initially, Orch OR is now supported by experimental results, including anesthetic action. In 2017, with Sir Roger Penrose, James Tagg, Ivette Fuentes, and Erik Viierre, Hameroff co-founded the Penrose Institute, intended to support research based on the various works of Sir Roger (cosmology, quantum mechanics, general relativity, black holes, geometry, and consciousness).

Stuart Hameroff's work is putting the “How” under our observations and the cognitive landscape we see.

Stuart Hameroff needs more computing power than anyone I know because he is actually trying to count the electrons in the human soul. He would disagree with that rendering, however, but reduced to one sentence, it is what is going on at the consciousness center. For your clarity, the electron exists both as a particle and a wave, and everything we talked about in our observations is waveform effects in a particulate environment. Here is the website

This leads to a new, non-local space, where the intelligence in the alien spacecraft we cannot deny any longer resides, just like we do. Billionaires are being asked to fund an acceleration in human evolution. Radin's involvement in DNA tracking of non-local consciousness genes foreshadows Commander Troy on a flight deck and humans in space, genetically advanced through the use of CRISPR.

There is so much more to connect, and so much that isn't connected. In the non-materialist category, we have stories about interaction with what Brian Weiss calls the masters, intelligence forms we can talk to non-locally. Stuart Hameroff can measure the body during these interactions, and this same holistic approach can be used to ask pointed questions about this science when we do these measurements. So, what we are trying to fund is to take Jim Tucker's children, Brian Weiss's regresses, and Pim van Lommel's NDEs into the lab for comprehensive studies. These forms of non-local consciousness can be used militarily for data acquisition.

We are coming to a point where our data management capabilities and our bodily information to store all the data of the body will be equal.

Our consciousness of birth and death is an upload download fractal of information management. This upload and download model is a fractal of birth and death the only difference being the amount of information. This fractal example becomes the methodology for the other fractals.

RFF 6 The University of Arizona College of Social and Behavioral Science 5 million dollars.

The College of Social and Behavioral Science, where the CCS is housed, has to be funded to study the global effects of our coming change of consciousness in terms of religion, society, and politics as completely as we can get it to publish a Standard Model of Consciousness, then teach it.

I want to make clear to you the importance of this particular contribution/donation and the point of keeping it separate and distinct from the contribution to the Consciousness Center. The school is/will be the central processing point for the information from the consciousness center. It is here that the information will be taught, and the impact of the new information about consciousness will be evaluated, implemented, monetized, and weaponized. It is a central clearinghouse for how the basic science is done at the consciousness center is processed, refined, and used. You can instruct the religious on how to rewrite the human belief system from this point because it will turn belief into understanding.

What follows is a simple factual account of what you could call The Standard Model of consciousness which all the contributors collectively produce. It posits that we live multiple lifetimes, our consciousness resides in and outside our bodies, and when we die, our consciousness is still discreet, meaning it is still you. The math proof changes religion because we have a better scientific understanding of the afterlife. However, religious law must be rewritten in many cases to accommodate our new factual knowledge. It changes our view on sexuality because life to life, we change gender regularly. As we incorporate this new view of consciousness into our reality, we encounter aliens who fly through our airspace, which we have documented. The asks; I would ask the college of Social and Behavioral Science.

The first ask is for them to compile and complete a book entitled The Standard Model of Consciousness in preparation for writing its curriculum. This needs to be taught at all levels. In it, they have to present an

inclusive look at our reality, including and not limited to the points in this proposal, so the landscape from children who remember previous lives, past life regression, and NDEs, include remote viewing and clairvoyance, and our understanding as best presented at the Consciousness center. This includes contributions by the scientists named in this document.

The second ask is to evaluate the social and political consequences of a reality that includes aliens and an afterlife. The ramifications must be part of the book, The Standard Model of Consciousness.

The interaction between CSBS and Prometheus would begin with a video prototype for classroom presentation written jointly by The College of Social and Behavioral Science and Prometheus to present all of the information on the science of extra-terrestrials and aliens and the various subcategories of each.

I would ask them to work with Prometheus Entertainment to produce educational videos on The Standard Model of Consciousness and its relevance in society for every variation of consciousness and in every language. In putting it on video, it can and will end up on every cell phone on the planet.

For the first time with a billionaire's contribution, there is cohesion among the disciplines of consciousness science, and the document produced becomes a teaching tool to a new generation so arguments advanced by JK Rowling and others can be refuted scientifically and mathematically. Let us say that there was a group of scientists who wondered if there was a DNA marker that indicated if someone was "gifted" when it came to non-local consciousness and suppose that these scientists had DNA samples taken from the best psychics they could find. It would be cheap to take the sample and send it to a lab. Let us also say that these scientists identified the DNA code for such an ability, much like finding the DNA marker for sickle cell anemia. And let us say that using CRISPR could enhance that non-local ability. In a simple experiment, they would be rendering homo sapiens into the past and introducing homo futurists. (Radin DNA)

The asks; I would ask Radin and the Noetic institute to contribute to the Standard Model of Consciousness and the 5 million is to further their work.

The SOC is based on the best available science and expert professional consensus.

The overall goal of the SOC is to provide clinical guidance for health professionals to assist transsexual, transgender, and gender nonconforming people with safe and effective pathways to achieving lasting personal comfort with their gendered selves in order to maximize their overall health, psychological well-being, and self-fulfillment.

Rainbow Railroad is a global not-for-profit organization that helps LGBTQI+ people face persecution based on their sexual orientation, gender identity, and sex characteristics. In a time when there are more displaced people than ever, LGBTQI+ people are uniquely vulnerable due to systemic, state-enabled homophobia and transphobia. These factors either displace them in their own country or prevent them from escaping harm.

Instead of just getting people to safety, they distribute to those points in the world the aggregate of the information included in this fund request.

The ask: They distribute A Standard model of Consciousness to explain that gender variation is normative among humans and not a disease; it's a common manifestation of consciousness.

What's going to drive this change is an organization to do it.

The Institute for Advanced Consciousness Studies TIFACS gets a one-million-dollar founder's grant. Its job is to implement the plan to raise 450 million dollars as presented in this proposal. This will be the organization that will manage the overall grant proposal for 450 million dollars. Its mission will be to manage the grants and collect and correlate the data to all organizations that would benefit from said information.

The Scientific Organizational Pyramid

TIFACS presents funding availability and opportunities for funding to the Consortium of Schools and organizations through the Consciousness Center at the University of Arizona and additionally through any university that houses a chair of consciousness study or a related field that the study of consciousness would encompass. The choices for programs to be funded are made through and by the scientists themselves in a collaborative manner so that a complete understanding of human consciousness is drawn to the best of our ability at the moment but encompassing all aspects of how our consciousness expresses itself.

Who is being asked and why?

All of these efforts must be coordinated to produce the standard model of consciousness in textbook form, teach it, and advance the solutions to human management it prescribes. There are several questions we need to address before we begin this.

1-If this is so important, why aren't we advancing an intelligent plan and facing squarely the reality unfolding before us? No political system on earth can address this.

2-Of the individuals who can see aspects of this consciousness research in all its forms, how are the efforts being coordinated?

3-Of the emerging paradigm, what is the response from the best minds we have to deal with this?

4-The point of everything I have written is to coordinate this effort of self-defense and self-discovery for a species, humanity.

Who I would initially invite initially to a consortium of billionaires.

Lawrence Rockefeller. Billionaire Laurance Rockefeller is financing what is billed as a scientific survey aimed to sort hoaxes from the purportedly truly mysterious crop circles.

Since 1978, patterns of matted-down cornstalks, rapeseed, and other crops have been appearing in the fields of Wiltshire and neighboring areas in England. Enthusiasts attributed the so-called crop circles to UFO landings. Many people still believe that some of the patterns, because of the speed of their appearance and their perfect geometry, must have a nonhuman origin (see home.clara.net/lovely/homepg.html).

There are 2 distinct varieties of crop circles and how they are created, one a human version of hucksters and responses and the other ones made by means we don't understand with an obvious signature of which is which. But what information is being exchanged?

Robert Bigelow Robert Bigelow has a deep understanding of this landscape and knows how to manage this type of venture within consciousness science. Begin the plan to fund 20 chairs of Parapsychology using your judges and the Center for Consciousness to select where the chairs should be placed and what funding they should get. I would ask that the first chair be placed at the University of Edinburgh and be called the Dumbledore chair. If each chair is funded for 10 million dollars, this would need 200 million dollars. McKenzie Scott, your 50-million-dollar donation is one ninth of the 450 million we need to fund consciousness research. The 450 million dollars number comes from Dean Radin's overall plan. This first 50 million is specific in its targets and its purpose.

Radin's plan is attached here. Your donation funds TIFACS to run other programs and other projects to seek those contributions to fill out the list of Radin's proposed needs.

Elon Musk Very simply, sir, this consortium of researchers can connect the mind to your neural net and do this research better than you at a lower price. I suggest outsourcing your needs to schools within the consortium that the Consciousness center represents.

I would like Mr. Musk to donate 100 million dollars to the University of Arizona Center for Consciousness Studies. This would filter through the Center into a global consortium of schools specializing in different aspects of consciousness. I would ask Mr. Musk first to call me so I could explain the landscape, and then call Stuart Hameroff, Nobel prize winner with Roger Penrose for their work in microtubules, to explore the areas that Mr. Musk needs help with.

Mr. Musk's project killed seven monkeys trying to connect to their brains. Rather than connect a device, one that harmonizes brain wavelengths may be better, and this consortium leads the world in this understanding bar none. To an investment guy, you are early on the arc of the commercial benefits of this, and within the consortium, there are cutting edges in different sub-categories. It may be opportunistic for you to also speak with Doctor Hameroff about what may be needed in support and what may develop from such support.

That said, change such as this has derivative effects down the line. To see the whole scope read Dr. Radin's plan for funding; the total tranche is 450 million. This overall proposal here attached represents the first 50 million nominal. Please call me first before you call Dr. Hameroff. It's not imperative; it will be helpful. I want to frame the landscape you are stepping into, sir; the military and business applications for what I just described are transcendent. This leads to a Remote Artificial Intelligence Viewer.

9 While organizations like IRVA, MUFON, and CSETI cover some aspects of this effort, they are not connected cohesively and are all underfunded. Additionally, the governments of the world hide and mishandle their own information. This affects us all, and a structure with open architecture and complete information is imperative to making an intelligent cohesive response to the emerging set of circumstances.

Bill Gates

There is none better to lead a global information processing effort, including AI and non-local consciousness.
